Thank you for your message dated March 23, 2021, sharing your support for Bill 62, *The Animal Diseases Amendment Act*, and Bill 63, *The Petty Trespasses Amendment and Occupiers' Liability Amendment Act*.

Our government introduced Bill 63 to support our efforts to modernize and improve Manitoba's trespass and occupiers' liability laws for all types of premises, and I am pleased to hear that you are supportive of this piece of proposed legislation. As you may know, our government hosted a public consultation on the important issues of rural crime, biosecurity, and metal theft, to gain valuable input from Manitobans that informed the development of this legislation.
